

## **Full Golf Members**

Full Golf Members are those persons or entities that have paid the required non-refundable membership initiation fee then in effect for a Full Golf Membership and who have been accepted as members by the Club. Full Golf Members will be entitled to use all of the Club Facilities. Full Golf Members will not be required to pay green fees but will be required to pay golf cart fees and other fees set by the Club. Full Golf members will be allowed to make a tee time up to 6 days in advance. The number of Full Golf Members in the Club is subject to the limitation set forth in the Club Operating Covenant.

## Junior Golf Members

Junior Members shall be those members aged thirty-four and under who have paid the required non-refundable membership Initiation Fee, then in effect for a Junior Membership and who have been accepted as members by the Club. Junior Membership and the payment of Junior Membership dues will entitle the Junior Member to use all of the Club Facilities. Junior Members shall be required to pay food minimums, golf cart rentals, caddy fees, locker rental fees and any other charges set by the Club from time to time in addition to Junior Membership dues, Junior Members will be required to upgrade to Full Golf Membership at the age of thirty-five by paying the difference between the Junior Membership Initiation Fee paid by such Junior Member and the Initiation Fee charged by the Club for a Full Golf Membership at the time that the Junior Member turns thirty-five.

## Sports Limited Members

Sports Limited Members are those persons or entities that have paid the required non-refundable membership initiation fee then in effect for a Sports Limited Membership and who have been accepted as members by the Club. Sports Limited Members will be entitled to use all of the Club Facilities. Sports Limited Members will be required to pay Sports Limited green fees and required to pay golf cart fees and other fees set by the Club. Sports Limited members will be able to make a tee time up to 3 days in advance.

## Sports Members

Sports Members are those persons or entities that have paid the required non-refundable membership initiation fee then in effect for a Sports Membership and who have been accepted as members by the Club. A Sports Membership allows the Sports Member to use tennis, swimming, exercise and other recreational facilities and to attend Club sponsored events held at the Clubhouse. Sports Members shall have the same advance sign-up privilege to reserve tennis court times as Full Golf Members.

## Health and Fitness Members

Health and Fitness Members shall be those persons who have paid the required non-refundable membership initiation fee then in effect for a Health and Fitness Membership and who have been accepted as members by the Club. Health and Fitness Members will be entitled to use only the dining facilities, the Family Activity Center, children's playgrounds, Fitness Center, Childcare Facilities, and swimming facilities.

## Social Members

Social Members shall be those persons who have paid the required non-refundable membership initiation fee then in effect for a Social Membership (except for Resident Owners in The Point, as defined below) and who have been accepted as members by the Club. Social Members will be entitled to use only the dining facilities, Family Activity Center, and children's playgrounds. Social Members may also participate in all social and children's events. CONTRIBUTION IS WAIVED FOR PROPERTY OWNERS, HOWEVER, IS NOT CONSIDERED A CREDIT TOWARDS ANY OTHER MEMBERSHIP LEVEL.

## **Corporate Members**

#### Membership Contribution-\$65,000

A Corporate Membership is a membership issued to an operating entity (i.e., a partnership, limited liability corporation, trust or corporation) with an on-going business purpose. The Corporate Membership will be issued in the name of the entity upon the acceptance by the Club of the Corporate Member and the Corporate Member's payment of the required membership initiation fee then in effect for a Corporate Membership. The Corporate Member will designate three individuals who will be permitted to use the Club Facilities in accordance with the terms of the Corporate Member's Application for Membership. All three designees of a Corporate Member will be permitted to use all of the Club Facilities. Each individual designated by the entity must either be a director, officer, partner, shareholder or employee of the entity and must submit an Application for Membership and be approved by the club. Dues must be paid for three corporate designees regardless of the number of corporate designees actually designated at any particular time. The entity may change a corporate designee upon payment of the re-designation fee charged by the Club. The Club reserves the right to establish from time to time all rules governing the designation of an individual as the corporate designee including establishing limits on the number of corporate designees may be changed. Corporate designees of a Corporate Membership and be approved by the designates, and on the number of times designations may be changed. Corporate designees of a Corporate Membership and payment of times designations may be changed. Corporate designees of a Corporate Member of membership and the corporate Membership are referred to herein as Full Golf Members or members except for the purpose of membership ownership.
